It is information about money that is available to help pay for work to support adult survivors of childhood abuse.



The fund is called the **Survivors of Childhood Abuse Support 2024** fund.



Starting now we will call it The Fund.





About The Fund



The Scottish Government is committed to funding services to support adults affected by childhood abuse.



The Fund will support third sector organisations currently delivering services to adult survivors of childhood abuse.



The aim of **The Fund** is for survivors to enjoy a safe and healthy life, with improved wellbeing.



The Fund builds on the work of SOCAS 2020 – 2024.







Outcomes of The Fund



The aim of **The Fund** is **survivors enjoy a** safe and healthy life, with improved wellbeing.

The outcomes of **The Fund** are:



- Survivors have improved health and wellbeing.
- Survivors feel an increased sense of safety and trust with their support and in their relationships.





Criteria of The Fund



The Fund will ask questions about the following:





- How you listen to the views of survivors
- The safe delivery of your services
- How you measure if your service is making a difference to survivors
- The amount of money you are asking for







Who can apply?



The Fund is for organisations delivering third sector organisations that support adult survivors of child abuse.



Organisations need to be charities or community run companies.



Money making businesses cannot apply.



Organisations forming a partnership can apply.

Only one application is allowed per organisation.





When will the money be available?



The Fund will start in October 2024.



The Fund will end in March 2026.







Year 1 will last from October 2024 to March 2025.







Year 2 will last from **April 2025 to March 2026**.







How much money is available?



The Fund anticipates a total amount of up to £3,345,000 will be available across 18 months:



Between **two to five** organisations with a grant of between £225,001 - £300,000.



Between **five to eight** organisations with a grant of between £150,001 - £225,000.



Between **five to eight** organisations with a grant of between **£75,001 - £150,000**.



Between **five to eight** organisations with a grant of up to £75,000.







How do I apply?




First, say that you are interested by clicking on this <u>link.</u>


